

**POLICY NAME: Adult Christian Education**

**1. Purpose:**

- 1.1. This policy ensures a framework to conduct Adult Christian Education at Deer Lake United Church

**2. Scope:**

- 2.1. This policy applies to all individuals involved in Adult CE at DLUC.

**3. Policy Statement**

- 3.1. Spiritually stimulating and challenging CE will be provided to adults attending DLUC.

**3.2. Procedures:**

- 3.2.1. There shall be opportunities for Adult CE at various times throughout the year.
  - 3.2.2. Adult CE will address the needs of the multi-generational members of DLUC.
  - 3.2.3. With input and cooperation between the CE Committee and the Minister, events (such as family campouts, Bible study, workshops etc) will be organized and conducted according to topics suggested by either the Minister, CE Committee or interested members of the congregation.
  - 3.2.4. There will be opportunities to invite guest speakers to talk about relevant topics and to reflect interests of the adults attending DLUC. Following each speaker an evaluation will be conducted to critique the event.
  - 3.2.5. The CE Committee will ensure confirmation classes are held annually for adults.
- 3.3. If at all possible DLUC will strive to offer Adult CE as a gift and a form of outreach. Cost should not be a deterrent to participation.
